## **Introduction:**

In modern democracies, people elect their representatives through the process of elections. Electoral success depends, along with other things, on high voter turnout. In other words, greater participation of people in elections means better results and the emergence of better political leaders. In developing countries of the world, normally, people are too occupied with winning their daily bread to bother about who gets into the corridors of power. Casting a ballot can mean waiting for hours in queues. In the face of stringent economic conditions, they consider it a waste of time to go and cast their votes. Whatever the reasons may be for low turnouts, it goes without saying that ballot is the means by which people can bring to power people who can deliver. Amid all this din and clamor, we forget to make elections accessible to Persons with Disabilities (PERSONS WITH DISABILITIES (PWDS)). Inaccessible elections leave out Persons with disabilities (PWDS) and they are unable to express their views, and to show their power of voting.

On May 11, 2013 SOCIETY FOR SPECIAL PERSONS tried to make special arrangements (Accessible Polling Stations) to set a model to ensure the active participation of the persons with disabilities in the General Elections 2013. Society for Special Persons held meetings with foreign and national teams of observers. It organized a dialogue on the political rights of the disabled in which people from various walks of life participated and stressed that PERSONS WITH DISABILITIES (PWDS) should be provided facilities during the elections. Representatives of political parties and the election commission also participated in the dialogue and assured that the recommendations of the dialogue will be considered in designing accessible elections.

## **Proceeding**

SOCIETY FOR SPECIAL PERSONS Multan- Pakistan arranged in two teams to observe the elections. One team was headed by Nadir Khan, the Vice President of the NGO. He worked from dawn to dusk and provided help to the disabled in getting access to the polling stations; the other team was headed by Zahida Hameed (president).

There were no availability of wheel chair for Persons with disabilities (PWDS) in the polling stations and no one told Presiding Officer to how he attend the person who is in wheel chair and stairs were there instead of ramp for Persons with disabilities (PWDS). Many Persons with disabilities (PWDS) did not cast their vote due to inaccessible arrangements.

There was no list of registered Persons with disabilities (PWDS) with presiding officer and observer could not know to know that how many Persons with disabilities (PWDS) are going to cast their vote and at which polling station.

## 1. Accessible Polling Station (Model)

SOCIETY FOR SPECIAL PERSONS had made special arrangement to ensure the smooth participation of persons with disabilities in the Election 2013 NA 149, Polling station 245 & 246, we utilized our own resources made, model polling station for the disabled voter we built ramp, brought wheelchairs to assist Persons with disabilities (Pwds) voters and facilitated disabled voters through attendant services.

Polling starts at 8:00 A.M. at the canal department office. Two teams of SOCIETY FOR SPECIAL PERSONS members arrived there at 7:45 A.M. with the passage of time voters' start coming to the polling station.



First team had list of Persons with disabilities (PWDS) who want to cast vote they have 3 vehicle and they provide them pick and drop facility from their houses to the polling both. Other team was in

the polling station and they provide them the facility of guidance and accessibility. SOCIETY FOR SPECIAL PERSONS's members made this polling station accessible through ramps on stairs and they also made ballot box accessible .they provide attairder ship from vehicle, provided them wheel chair and took them in the polling station and gave them all attendance they needed i.e (the physical handicap persons) . When any visual impaired person arrived to the polling station with first team than the second team took them and gave them complete attendance. They provided them in the polling station and helped them through complete procedure in casting their vote to their decided candidate. When any hearing impaired person arrived to the polling station, our members provided them a sign language expert attairder, who help them in complete procedure to cast their vote.

The teams included people with hearing and sight impairment. The teams arranged three vehicles with self help bases. They had four wheelchairs in the vehicles. They went to homes of various Persons with disabilities (PWDS) and brought them in their vehicles to polling stations. When they visited various polling centers, they came to know that the officials had no knowledge about the number of disabled people living in their constituency. There were no ramps and no wheelchairs. Some polling stations had placed the ballot box on the first floor of the buildings, with no ramps leading to it. Therefore, Persons with disabilities (PWDS) could not access the ballot boxes in such buildings. No guidance had been

provided to the presiding officers of the polling stations about how to serve PERSONS WITH DISABILITIES (PWDS).

They had no knowledge of how many disabled voters had been registered in their constituency.



The volunteers realized that the election officials should develop data about the whereabouts of the Persons with disabilities (PWDS) so that volunteers can easily help them come to polling stations. They also realized the importance of setting up a

communication centre where the problems of the disabled could be communicated.



The volunteers of the NGO also talked to the election officials and requested them to improve election accessibility for the disabled.

They've not only observed the provision of disabled-friendly facilities but they've also set up a model polling station where they provided ramps and wheelchairs for PERSONS WITH DISABILITIES (PWDS)

At this polling center, they've invited Persons with disabilities (PWDS) to do their part for the nation despite their disabilities. Thus, a good number of Persons with disabilities (PWDS) have turned up on the polling station to vote for their favorite candidates. Kind-hearted volunteers have provided them with wheelchairs.



With the help of ramps, the persons with disabilities could smoothly wheel through the various procedures required for ballot.

Zahida Hameed said, 'At the model polling station for the disabled, there are people that who had never cast their votes in life. This is an important day in the history of the country because today the disabled have not only casting their votes for the first time in life but have helped other Persons with disabilities (PWDS) in casting their votes at

the model polling station. She stressed that the disabled should have their representatives in the parliament of the country because the disabled are also part of the society.

The NGO officials stress that the disabled can influence the formation of government in the country through their votes. The election officials should develop data about the disabled. The election commission should provide resources to the volunteers and training to its staff on how to handle the disabled when they come out to vote. This model polling station was the first 'drop of rain'. They hope that election officials will set up similar polling stations for Persons with disabilities (PWDS) across the country in future.

The NGO representatives assert that Persons with disabilities (PWDS) are actually 'uniquely baled' people. But, most of us fail to see how this is so. Although some parts of their bodies are paralyzed, it does not mean that they are not sensible enough to cast their votes. These people do go through difficulties. They have their opinions that should be brought forth. If they have no say in the political process of the country, their suffering is likely to be multiplied. They have a right to ease of voting and we should try, in countries where this issue is present or prevalent, to improve the voting experience for the disabled. The same officials maintain that elections can be made more accessible with new Web technologies, through the use of which, disabled individuals could vote from the comfort of their homes.

1. Accessibility is largest barrier in Pakistan, the polling stations were not accessible for a



PERSONS WITH DISABILITIES (PWDS) but if included help of two to three persons from society then yes, we can say that the polling stations were accessible.

2. Their attitude towards Persons with disabilities (PWDS) is becoming positive and this is what we observed in

polling stations, the positive approach of presiding officers, the cooperation of policemen and guards standing at the gates really filled up the gap of accessibility issue.

3. Informational barrier hasn't been of concern because television is the best mode of information that lives in our houses and our media has done this job of spreading information remarkably well.



The Persons with disabilities (PWDS), we talked to in polling stations were fully aware of where to go and what to do already, they didn't have any doubt about voting criteria

and methodology in their minds. Above all, the election officers in polling stations were also helpful in this aspect and they provided their full support to PERSONS WITH DISABILITIES (PWDS) as the request by SSP.

Despite of all the barriers and obstacles, we were astonished to see that a lot of Persons with disabilities (PWDS) participated in Elections and they proved

to be an important and integral part of our society..

## Lack of facilities discouraged PWDs from casting votes

In some instances polling booths were inaccessible, no wheelchairs were available

The Election Commission of Pakistan (ECP) violated its strategic goal by not making polling stations accessible to persons with disabilities (PWDs) across the country, depriving them of their legal right to vote due to which their turnout remained less than one per cent.

Civil society representatives who observed elections from a disability perspective told *The Express Tribune* that before the general election 2013 the ECP had assured them that all polling stations would be made accessible to PWDs

under its strategic goal number 14, “Marginalised Groups including Women, Minorities and Persons with Disabilities” aimed to ensure their participation in the

electoral process.

They said the majority of polling booths lacked facilities such as wheelchairs, ramps and staff to assist persons with sight or hearing impairment.

Zulqarnain Asghar, advocacy and communications manager at Initiative for Raising Awareness, Development and Assimilation of the Handicapped said a polling booth was established on the first floor of Asif Public School, Rawalpindi in NA-52 which was inaccessible for PWDs.

Another polling booth set

up in Aisha Lasani Model School Rawalpindi had no ramp and a polling station set in Asif Public School was located in a very congested place where it was difficult to move about in a wheelchair.

Sharing his experience, he said the returning officer at Asif Public School was not aware of the special computerised national identity cards for PWDs. “Some PWDs who were first-time voters were deprived of their right due to lack of facilities,” he said.

Special Talent Exchange Programme (STEP) President Atif Sheikh said his team

disabled people observed the election process at 139 polling stations from a disability prospective in 15 districts

visited polling booths established in some areas of C-Sector and observed that they were all inaccessible to PWDs.

He said STEP in collabora-

tion with other NGOs formed a team of 80 people who all were suffering with various forms of disabilities and observed the election process at 139 polling stations from a disability prospective in 15 districts.

Society for Special Persons President Zahida Qureshi, who is based in Multan, said, “We utilised our own resources and made model polling stations for the disabled. We built ramps and brought wheelchairs to assist persons with physical disabilities.” She said none of the polling booth she and her team visited were disabled-friendly.

## **Suggestion from Persons with Disabilities Voters**

1. There should be legislation for rights of Special People and their active playing role in society.
2. List of disabled persons should be with Presiding Officer in elections.
3. There should be information cell for Persons with disabilities (PWDS) in elections.
4. Communication gape also creates hurdles, to remove this problem there should be a person for attending Persons with disabilities (PWDS) and help them to casting their vote.
5. There should be complaints hearing person at polling stations.
6. ECP have to arrange meetings with Persons with disabilities (PWDS) before one Month of elections for make ensure accessible polling station.

## **Expected Outcomes**

1. To take this step in history of Pakistan will be written in golden words because the disabled are in the activity of vote casting.
2. Most important is that the disabled persons are being attended by the persons same (disabled) like them.
3. Many Persons with disabilities (PWDS) casted their vote with help of their friends.
4. Media coverage is a clicking sign to Election Commission and as well to Govt. of Pakistan to take attention for Special people for vote casting.
5. Persons with disabilities (PWDS) observers also took part in elections to make elections easy and accessible for other PERSONS WITH DISABILITIES (PWDS).
6. Disabled people first time participated in election as an election observer that is good sign for the empowerment of disabled people
7. A large number of Persons with disabilities sensitized their political rights, and they casted their votes.
8. Society for Special Persons set a good example of self reliance to develop a Accessible polling Station as a Model for voters with Disabilities and community.
9. People (Male/Female) were sensitized and aware about the accessibility of Persons with Disabilities as the result of this model polling station organized by Society for Special Persons
